- 2008-12-07 00:00:00 The NOAA Office for Coastal Management (OCM) received files in LAS format. The files contained LiDAR intensity and elevation measurements. OCM performed the following processing on the data to make it available within Digital Coast: 1. The data were converted from UTM coordinates to geographic coordinates. 2. The LAS header fields were sorted by latitude and updated. 3. The data was filtered to eliminate outliers.
