- 2021-03-13 00:00:00 - Orthorectified image frames of the four-band imagery were generated using SOCET GXP. Four-band orthomosaics were generated and clipped out to ortho tiles using GeoMedia OrthoPro. Mosaic data have not been histogram stretched. The orthoimage tiles are 1 km by 1 km squares and are 8 bits per band. Data are projected in NAD83(2011)/UTM 20 North.
