- 2018-01-01 00:00:00 - Orthophoto Processing: Utilizing all four bands [blue (B), green (G), red(R), and near infrared [NIR]] digital orthorectification was performed using bilinear interpolation algorithms resulting in a spatial and radiometric transformation of the digital image from line/sample space into NAD83 (2011), UTM Zone 18N, Meters. The interior and exterior orientation parameters from the aerotriangulation process were used to project each pixel into the ground coordinate system, while the ortho grade DTM was used to correct for relief displacement. Radiometric correction software and techniques were used to create orthophoto files that minimize the appearance of image seams and without loss of feature signature. Orthophotos are checked for geometric accuracy, image quality, and are tonally balanced to produce a uniform contrast and tone across the entire project. The individual overlapping orthophoto frames were mosaiced together
