The source imagery was acquired from 20230521 - 20240520 with an Applanix Digital Sensor System (DSS). The original images were acquired at a higher resolution to support the final ortho-rectified mosaic.

Process Steps:

- 2024-07-23 00:00:00 - Mosaic's were generated from 4-band (red, green, blue, near-infrared) ortho-rectified imagery. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit RGBI.

The DEM source is 30 meter posting USGS NED. Cubic convolution resampling method was used to create the final ortho-rectified mosaic. Original image tiles are 3.0 km by 3.0 km squares.
