Over 24,000 digital still frame photographs were taken simultaneously to LIDAR acquisition. Latitude and longitude were captured and logged with each photograph. Latitude and longitude were extracted from the photo log file and converted to polylines to create 'pseudo' track line file.

simultaneously to LIDAR acquisition. Latitude and longitude were captured and logged with each photograph. Latitude and longitude were extracted from the photo log file and converted to a point file. Using ET Tools, the points were converted to polylines using a unique identifier in the photo log to segment the arcs and to create 'pseudo' track line file.
