Process Steps:

- 2005-01-01 00:00:00 - Navigation information (along with time stamp) was extracted from digital overlay of video tapes recorded on Mini-DV media. A point file was created in ArcInfo 9.1 depicting the assumed position of the Delta. Video tapes were reviewed making note of primary and secondary substrate types, along with certain biological notations when deemed appropriate. Time stamp was noted on the video tapes at each substrate transition and assumed to remain constant

until the next transition in sediment type was encountered. Substrate type was entered into an Excel spreadsheet format where timestamp was used to correlate sediment with positional information. Navigation information (along with time stamp) was extracted from digital overlay of video tapes recorded on Mini-DV media.

A point file was created in ArcInfo 9.1 depicting the assumed position of the Delta. Point file was converted to line file. Video tapes were reviewed making note of primary and secondary substrate types, along with certain biological notations when deemed appropriate. Time stamp was noted on the video tapes at each substrate transition and assumed to remain constant until the next transition in sediment type was encountered. Substrate type was entered into an Excel spreadsheet format where timestamp was used to correlate sediment with positional information.
