


GROUND FISH FISHERY IN THE EXCLUSIVE ECONOMIC ZONE OFF ALASKA
PROHIBITED SPECIES DONATION PERMIT

AUTHORITY: Title 50, Code of Federal Regulations
Section 679.26 - Prohibited Species Donation Program

DISTRIBUTION OF PACIFIC SALMON CAUGHT INCIDENTALLY
TO ECONOMICALLY DISADVANTAGED INDIVIDUALS

The Administrator of the Alaska Region of the National Marine Fisheries Service (NMFS), acting on behalf of the Secretary of Commerce, issues SeaShare a Prohibited Species Donation Permit. This permit authorizes SeaShare to distribute to hunger relief agencies, food bank networks, or food bank distributors, Pacific salmon caught incidentally in the groundfish trawl fisheries in the Bering Sea and Aleutian Islands management area (BSAI) and Gulf of Alaska (GOA). The United States exercises fishery management authority in the 3- to 200-nautical mile exclusive economic zone of the BSAI and GOA management areas under the authority of the Magnuson-Stevens Fishery Conservation and Management Act, 16 U.S.C. 1801, *et seq.*; and implementing regulations at 50 CFR part 679. The permit holder must comply with the provisions of the Prohibited Species Donation Program at § 679.26. A list of all vessels and processors participating in the Prohibited Species Donation Program is attached. Participating vessels may deliver to any participating processor under this permit. This permit is valid until May 25, 2026 unless terminated or modified earlier by regulatory action pursuant to 50 CFR part 679, or revocation, suspension, or modification pursuant to 15 CFR part 904.
