Dear Chairperson Murphy:

Thank you for your letter requesting a determination of a fishery resource disaster for the 2023 Klamath river salmon fishery.

The National Oceanic and Atmospheric Administration's National Marine Fisheries Service evaluated information from the impacted fishery. Upon review, I have found that the request for a subsistence and ceremonial fishery resource disaster for the 2023 Pulikla Tribe of Yurok (Tribe) People Klamath River salmon fishery in California meets the requirements under the recently enacted Fishery Resource Disasters Improvement Act, which amended section 312(a) the Magnuson-Stevens Act (MSA).

In order to have a positive determination, there must be a fishery resource disaster from an allowable cause. Due to several factors such as prolonged and historic drought, severe wildfires, negative impacts to spawning and rearing habitat, harmful algal blooms, and shifts in ocean forage and associated thiamine deficiency, there was a loss of access under the MSA in this fishery. The factors mentioned caused the Tribe's Klamath River salmon fishery to experience a total closure of the subsistence and ceremonial fishery in 2023. The lack of a subsistence and ceremonial fishery resulted in severe subsistence and cultural impacts for the Tribe. Therefore, this fishery meets the requirements for a positive fishery disaster determination.

This determination now makes the 2023 Pulikla Tribe of Yurok People Klamath River salmon fishery eligible for fishery disaster assistance. Should the Department of Commerce receive congressional appropriations for fisheries disasters, the Department of Commerce will consider allocations of disaster assistance for this fishery. In addition, eligible businesses and other tribal entities may be able to access other loan/funding programs through other Federal relief programs (e.g., Small Business Administration loans). Programs within the Department (e.g., Economic Development Administration grants) may also be available.
